5. Discussion

- 1. **Ten-Year Rule** Christine Bryan, UG Admissions; State is offering free CC tuition for students over age 26. At the last meeting, Pauline Christakis and Angela Valvis spoke of the issue of students being accepted with transfer courses, and then departments rejecting courses. Nancy Ludwig mentioned if we don't accept a course, it is time and cost \$1100 for the student; there are courses that might be able to be accepted. Mai Nguyen shared that depts review courses each year. Paula Haines asked if the committee could share with transfer coordinators a guideline for evaluating transfer credits. Mary Kate Keyes asked if the rule is UMass systemwide; it is not. Christine suggested starting with the major. Michelle Hunt suggested starting with Core Curriculum courses, as we want students to be current with their major and we could have more flexibility with Core. Kevin Petersen suggested we may need a new university-level policy; Start by asking all depts to identify their pain points. The committee does not want to have unintended consequences of working against our CC partners' completion rates. There was discussion of courses that are pre-requisites and courses that are not. The committee has personnel and process questions, including transfer coordination. The committee will continue the discussion.
