College Policy: FCOE Professional Development Seminar (James Sherwood) Change Policy https://uml.curriculog.com/proposal:1918/form Less than 30% of students are taking advantage of the co-op program; Jim hopes this will help. Students will gain job skills, interview skills, and build their resume. The hope is to increase 15% over the next three years for 75% participation rate. The committee expressed concern about how to incorporate the proposed policy into Degree Pathways. Departments will need to modify; one size does not fit all. The committee expressed the need to be clear how students will fulfill this requirement. Carol Myers asked how many students there are and if there will be enough coops. Jim stated there are 2500 Engineering students; This will impact 600-700 new students, plus transfer students. Karoline Evans asked what counts as a professional development experience and who signs off on that? Mike Geiger shared that departments have been talking about this for a while. Mai Nguyen mentioned that the policy doesn't have to go into effect for all depts in FA24, and it may not need to go to DHE if it is a college-level.
