

UMASS LOWELL DATA CLASSIFICATION – STORAGE OPTIONS

Storage Definitions

One Drive for Business is a document storage, management, and collaboration tool with a contract and Business Associates Agreement with the university to cover sensitive data. Individuals are responsible for configuring One Drive in compliance with data regulations, including HIPAA, human subject data restrictions, and other data use agreements.

Local Computer Drive – C: drive is the hard drive on your computer. This drive must have Full Disk Encryption enabled

Network File Share – Z: drive is a personal folder maintained by UMass Lowell IT; protected by campus firewalls and Active Directory security groups

Department File Share – X and Y drives are departmental network file shares maintained by UMass Lowell IT; and protected by campus firewalls with Active Directory security groups

Exchange Email are email and/or calendaring services provided by UMass Lowell IT and hosted on campus.

Public-Facing UMass Web Sites & Blogs are university-owned services, but their public nature makes them unsuitable for storing sensitive data.

Cloud Storage Services without a contract with the university, including Dropbox, Box.net, Amazon Cloud, or other commercial data services, are not appropriate for storing most university data.

Cloud Storage Services with UMass Lowell Contract: Some commercial cloud storage services hold contracts with UMass Lowell. Each contract will stipulate the vendor's responsibilities regarding university data. Check with your department chair to find out more about each service's contract. UMass Lowell Information Security should review the Information Security requirements before use.

Secure Storage Options: Your department may have chosen a secure storage solution for all sensitive data (e.g., a secure file server). Check with your supervisor or department chair for more information. UMass Lowell T also offers a secure storage service for a fee. Department chairs and IT professionals can contact the UMass Lowell Information Security to discuss the best storage option(s) for their department.
